CALL THE MEETING TO ORDER

The publishing of the scheduled AGM in the March/April Art Avenue magazine and on the FCA website constituted proper notice to the membership. A quorum being present, the Chair, Andrew McDermott SFCA, called the meeting to order at 6:00pm.

REPORTS

1. President's Report – Andrew McDermott – Report Read and Handed Out at Meeting Welcome to all and best wishes to Elaine Chatwin who is stepping down as secretary this year. Highlights for 2013 include the online gallery now available to members and the Whistler workshop in September. Many thanks to Susie Cipolla, committee members and volunteers for all

the work on the Whistler workshop.

- 2. Standards Committee Report Teressa Bernard Report Read at Meeting The newly appointed Standards Chair reported that the post signature application critiques in the gallery are completed. The online critiques are still in progress due to email program difficulties. Teressa spoke directly with Robert Coulter to acknowledge receipt of his letter voicing concern over the recent FCA decision to discontinue digital entries for the time being.
- 3. Gallery Director's Report Mila Kostic Report Read at Meeting
 The Gallery Director gave an overview of the goals of the gallery and the standard exhibitions that run each year as well as the new exhibitions that create such diversity. Attendance at the Gallery in 2012 was reported as general admission: 27,662; special events & openings: 577; and statutory holidays: 764. The online commercial gallery is up and running and will continue to be developed. The jurying of Chapter shows and Gallery rentals continue as sources of revenue for the FCA. Many thanks to volunteer organizer Joyce Friar and all the dedicated volunteers helping to run the Gallery.
- 4. Executive Director's Report Bev Schenke Report Read at Meeting
 An overview of FCA financials highlighted a much smaller deficit of \$7,000 in 2012 compared to \$31,000 in 2011. Liabilities for 2012 were \$68,154.07 compared to \$126, 612.84 in 2011. The education program struggled through 2012. Although the Salt Spring Workshop and PBN fundraiser helped with revenues, a much larger positive income flow is one area that needs continued effort in 2013. Eleven new AFCA and 3 new SFCA members were recently welcomed for a total of 119 AFCAs and 38 SFCA current signature members. Total membership now sits at 2,013 from across Canada, the USA, UK, Indonesia, Iran and China. The FCA is thankful for donations from members, vendors and contractors as well as volunteer hours from members and those on the Board of Directors. A special note of thanks to the Thompson/Nicola/Shuswap Chapter for the open show that it has hosted for 6 years. Thanks to the Art Avenue stuffing team and reception volunteers. The FCA bookkeeper, Mary Yee, and chartered accountant Catherine Der oversee the accounting records with dedication. The economy is a tough one and is slow to recover but we are always looking for new ways to meet the goals for the FCA.
