## ELIGIBILITY

---

Digital Imagery Exhibition is an open, international, juried exhibition of original digital images, open to all living artists worldwide, working in digital, computer generated art. Entries must not be copies, derivatives, or based in any way on other copyrighted or published paintings, photographs or other artistic works. No photographs, although a photograph may be incorporated into the completed art work. This is not a digital photography show. Images can be printed on any 2 dimension substrates such as fine art paper, watercolour paper, photograph paper, canvas, aluminum or paper on panel. Works on paper or aluminum must be framed under glass. Works on canvas and paper mounted on panel must be varnished. They must be entirely the work of the entrant, executed without the supervision of an instructor. Work must not have been previously exhibited in any other FCA exhibition. All work must be for sale and priced in Canadian funds with intent to sell.

\$15.00 per image

Non-refundable entry fees in Canadian dollars only.

Up to FOUR images may be entered and all four can be selected.

## CONDITIONS

Submission of entry in this competition automatically constitutes the entrant's acceptance of all competition rules. The juror's decision will be final.

## ACCEPTED WORKS

Artists may not substitute another work for an accepted work nor alter the painting or the sale price. FCA reserves the right to refuse to hang any painting that does not match the original entry.

Entries that are accepted for exhibition must remain on display until 4 pm, December 7th, 2014. Awards will be mailed to those winners unable to attend the awards ceremony. Awards must be accepted as granted.

All work must be for sale and priced in Canadian funds with intent to sell. A commission of 35% will be retained by the FCA on all sold work. Artist's price should include this commission. Artists must advise the FCA of their GST number if they are registered.

Shipping of paintings to and from the exhibition is the responsibility of the artist. Work can be hand delivered or shipped. The Federation of Canadian Artists and its sponsors are not responsible in any way for the acts or omissions of any shipping agent.

Artists are responsible for loss or damage however caused. Artists are therefore encouraged to arrange adequate insurance coverage against such risks. The FCA and all exhibition sponsors shall not be found liable for any loss or damage, whether or not caused by their negligence. The FCA takes every measure to avoid damage and protect the artwork kept in the gallery.

The image of any accepted work will be retained by the FCA. The artist's signature on the entry form grants the FCA the right to use the image of the accepted work for publicity, educational and reference purposes. Copyright remains the property of the artist. All inquiries regarding copyright will be referred to the artist.
