# **ABOUT PAINTING ON THE EDGE 2015**

Now in its 13<sup>th</sup> year, Painting on the Edge or POTE (*poh-tee*) as it has become known by members of the Federation, is a yearly invitation to artists to challenge themselves and their audiences. Artists are encouraged to take an unconventional approach when considering their subject matter and technique. This exhibition and competition is an open call to artists working in all two dimensional drawing and paint-based mediums.

All successful entries obtain a Qualifying Point towards Signature Status applications with the Federation of Canadian Artists.

**Allowed Mediums**: Oil, acrylic, and watercolor painting, pastel, graphite, pencil, ink, and mixed media. Media specifically excluded are photography, digital photography, digital art, and etching. All work must be 2-dimensional.

**Theme:** Challenge. Challenge yourself in your art practice and challenge the viewer through unconventional technique and/or subject matter.

# **GENERAL SUBMISSION GUIDELINES**

Entries must be originals not based on copies, derivatives or other copyrighted or published paintings, photographs or artistic works unless the artist has express permission from the photographer / artist. We do not accept photographs, giclée, posters or any other type of mechanical reproduction. Please contact the FCA if you have any questions about eligibility.

Members may not enter a piece that was the result of a workshop or class. Only work that is new to the Federation Gallery may be entered into juried shows with the exception of "Success!' and "Summer Gallery".

**Size:** Artists wishing to submit triptychs or diptychs should be aware that due to size restrictions, only two triptych / diptych pieces over 48" total linear ft. will be accepted and displayed.

**Frame:** All environmentally sensitive artwork must be framed under glass, or alternatively varnished to an archival standard.

All paintings must be delivered ready to hang. The FCA reserves the right to refuse display of works that arrive unwired, incorrectly improperly framed or in disrepair.

**Submitting Information:** All information provided by the artist at the time of submission is final. The artist is responsible for ensuring that the information provided at the time of submission is correct.

This includes the correct orientation for and clarity of uploaded JPEG images. Images submitted that are blurry, poorly cropped, display the frame, or are the wrong orientation may be declined without refund.

The FCA will not change prices, titles, or submission information (including if the work is framed or unframed) after the artist has provided it. Attempts to change information after a submission is complete, or when the artist delivers a work will not be honored. Artists are reminded that your label, show list and online information is generated from the information provided at the time of submission, so please ensure to proof read your submission details before completing your submission.
