ABOUT "SKETCH"

Stripped of detail, sketches are creative pieces that carefully consider the visual language of line, composition, perspective, value and colour. Sketches often capture fleeting moments or feelings and as such can often leave deep impressions. A fundamental technical skill and a vital part of the artist's repertoire, sketching is the ability to quickly record an impression of a person, place, object or moment. "Sketch" the exhibition, highlights and encourages creative exploration of mediums utilised when sketching.

Allowed Mediums: Graphite, pen, ink, pencil, charcoal, watercolour, pastel, acrylic, oil. Excluded mediums are photography, digital photography and digital art.

Theme: Sketch. Artists are encouraged to creatively explore the process and mediums used for sketching.

GENERAL SUBMISSION GUIDELINES

Entries must be originals not based on copies, derivatives or other copyrighted or published paintings, photographs or artistic works unless the artist has express permission from the photographer / artist. We do not accept photographs, giclée, posters or any other type of mechanical reproduction. Please contact the FCA if you have any questions about eligibility.

Members may not enter a piece that was the result of a workshop or class. Only work that is new to the Federation Gallery may be entered into juried shows with the exception of "Success!' and "Summer Gallery". All pieces must be available for sale with the intent to sell and prices listed in Canadian Dollars.

Frame: All environmentally sensitive artwork must be framed under glass, or alternatively vamished to an archival standard. All pieces must be delivered ready to hang. The FCA reserves the right to refuse display of works that arrive unwired, incorrectly improperly framed or in disrepair.

Submitting Information: All information provided by the artist at the time of submission is final. The artist is responsible for ensuring that the information provided at the time of submission is correct.

This includes the correct orientation, lighting for and clarity of uploaded JPEG images. Images submitted that are blurry, poorly cropped, display the frame, or are the wrong orientation may be declined without refund.

The FCA will not change prices, titles, or submission information (including if the work is framed or unframed) after the artist has provided it. Attempts to change information after a submission is complete, or when the artist delivers a work will not be honored. Artists are reminded that your label, show list and online information is generated from the information provided at the time of submission, so please ensure to proof read your submission details before completing your submission.

Entry fees are non-refundable and accepted in Canadian dollars only \$15.00 per image.



DISPLAY PERIOD

Artworks will hang in the Federation Gallery from July $21^{\rm st}$ – August 16th. By submitting to this exhibition, the artist agrees to display their work for the duration of the exhibition. Artists collecting directly from the gallery after the exhibition has ended can collect on the last day of exhibition until 3pm. Thereafter artworks will be available for collection as of **August 20**th.

CONDITIONS

Submission of entry to this exhibition automatically constitutes the entrant's acceptance of all competition rules. The juror's decision is final.
