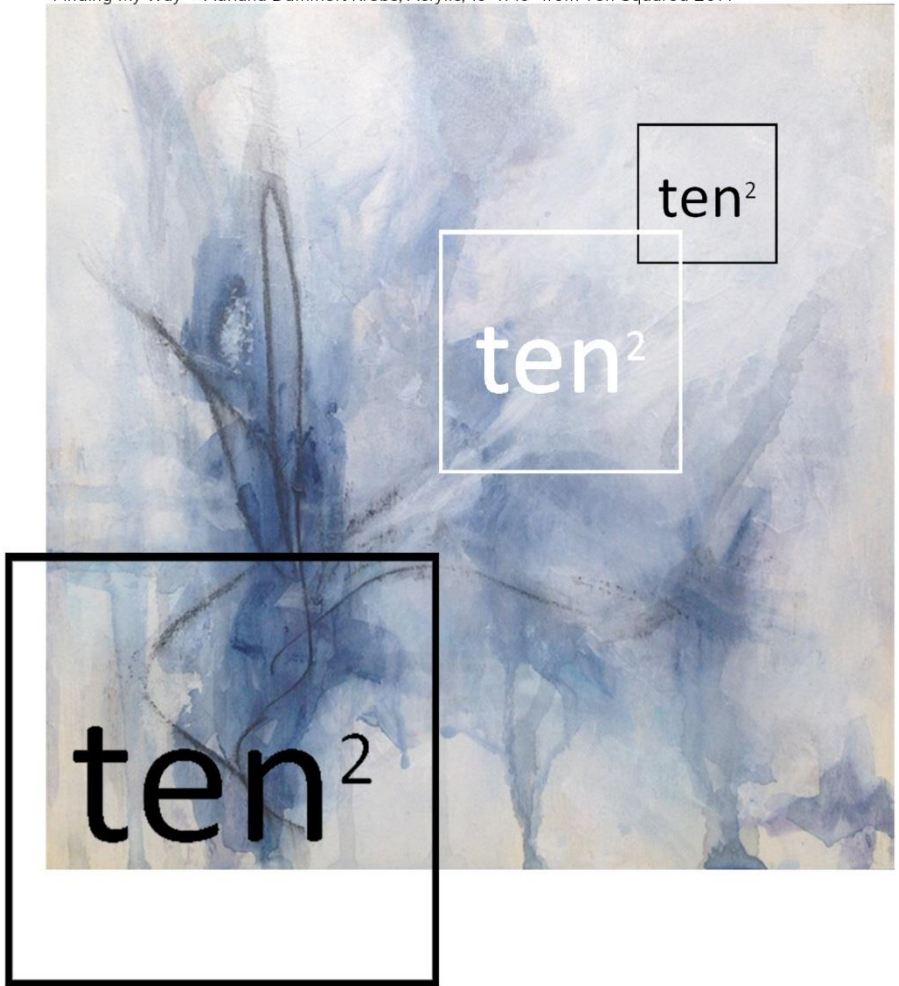

ABOUT Ten2

Ten2 or “ten squared” is a fundraising exhibition for the Federation of Canadian Artists. In this non-juried exhibition artists can submit pieces that are exactly 10” x 10”. The FCA retains a 50% commission on the price of all sales. Artists can choose to donate 100% of the sale price to the Federation in support of their fundraising efforts that allow us to provide:

- **18 – 20 exhibitions annually, free for visitors to enjoy**
- **Workshops, educational programs and professional development courses for artists**
- **Free family and children’s activities for cultural community events**
- **FCA annual competitions AIRS and Painting on the Edge**
- **And more besides!**

Entries do not qualify as a point towards Signature Status applications with the Federation of Canadian Artists.

Allowed Mediums: Oil, acrylic, and watercolor painting, pastel, graphite, pencil, ink, and mixed media. Etchings must be 1 of 1. Media specifically excluded are photography, digital photography and digital art. All work must be 2-dimensional.

Content: The FCA reserves the right to refuse to hang any painting that does not match the original entry. While un-juried, all entries will be gently screened for quality.

Frame: All submissions must be unframed. All artwork must be delivered ready to hang. The FCA reserves the right to refuse display of works that arrive unwired, damaged or in disrepair.

Price: All artworks must be priced \$150 CA.

Theme: N/A

Signatures: Please sign all submissions with your signature.

Size: 10” x 10” on gallery wrapped canvas or wooden cradle.

Submission Options:

There are two submission options for Ten2. Please consider donating 100% of your sales proceeds to support the Federation of Canadian Artists' fundraising efforts. If you decide to donate 100% we'll waive the submission fee.

Option 1: Artists pay a \$10 submission fee per item and receive 50% commission from sales

Option 2: Artists pay no submission fees agree to donate 100% of proceeds from sales to the Federation

GENERAL SUBMISSION GUIDELINES

Entries must be originals not based on copies, derivatives or other copyrighted or published paintings, photographs or artistic works unless the artist has express permission from the photographer / artist. We do not accept photographs, giclée, posters or any other type of mechanical reproduction. Please contact the FCA if you have any questions about eligibility.

All artworks must be available for sale with the intent to sell and prices listed in Canadian dollars.

Submitting Information: Artists cannot change details on their submission after the deadline for entries has passed. The artist is responsible for ensuring that the information provided at the time of submission is correct. This includes the correct orientation for and clarity of uploaded JPEG images. Images submitted that are blurry, poorly cropped, display the frame, or are the wrong orientation may be declined.

The FCA will not change prices, titles, or submission information after the submission deadline has passed. Attempts to change information after this time, or when the artist delivers will not be honored. Artists are reminded that their label, show list and online information is generated from the information provided at the time of submission, so please ensure to proof read your submitted details before completing the submission.

HOW TO ENTER

Submissions accepted online only at www.artists.ca be sure to select your preferred submission option as outlined below:

ENTRY FEES

Donation Option	Donated Commission %	Fee
Option 1	50%	\$10 per item
Option 2	100%	Free

Artists can upload five images and deliver all five artworks. You do not need to wait for confirmation or acceptance but must submit online before delivering. FCA staff will not submit for you. A minimum of three works per artist will display at one time during the exhibition.

Submission of entry to this exhibition automatically constitutes the entrant's acceptance of the guidelines and rules outlined in this booklet.
