GUIDELINES SPECIFIC TO THIS EXHIBITION

Ten Squared is an annual fundraising exhibition for the Federation of Canadian Artists. In this non-juried exhibition artists can submit pieces that are exactly 10" x 10". The FCA retains a 50% commission on the price of all sales. Artists can choose to donate 100% of the sale price to the Federation in support of their fundraising efforts that allow us to provide:

- Over 20 exhibitions annually, free for visitors to enjoy
- · Workshops, educational programs and professional development
- · Free family and children's activities for cultural community events
- · FCA annual competitions AIRS and Painting on the Edge
- · And more besides!

JURY: This exhibition is non-juried and gently screened by the Standards Committee.

FRAME: Unframed artworks only.

MEDIA: Acrylic, graphite, ink, mixed media, oil, pastel, pen, pencil and watercolour. Hand pulled prints in runs of up to 200. Please state the print number and run in the "description" part of the online submission form. All artwork must be two dimensional.

SUPPORT MEDIUMS: Gallery wrap canvas, canvas board, wood panel. Entries on paper are accepted if they are mounted to canvas board or a wooden panel or cradle. All works must be wired. For works on canvas, please ensure all staples are on the back and that the artwork either carries around all edges or that the edges of the canvas are painted.

EXCLUDED MEDIA: Photography, digital photography, digital prints, digital art, posters, giclée and mechanical reproductions.

Price: All artworks are to be \$150 CA

SIZE: 10" x 10" exactly

STYLE and SUBJECT MATTER: Any style and subject matter.

Entries do not qualify as a point towards Signature Status applications with the Federation of Canadian Artists.

Submission Options:

There are two submission options for Ten2. Please consider donating 100% of your sales proceeds to support the Federation of Canadian Artists' fundraising efforts. If you decide to donate 100% we'll waive the submission fee.

Option 1: Artists pay a \$10 submission fee per item and receive 50% commission from sales

Option 2: Artists pay no submission fees agree to donate 100% of proceeds from sales to the Federation

GENERAL SUBMISSION GUIDELINES

COPYRIGHT: Artwork submitted for jury that makes substantive use of the artwork of another artist or photographer will not be accepted for jury unless express permission for use is granted by the original artist/photographer or the reference material is within the public domain.

All artists submitting to Federation Gallery must sign the entry form which, among other things, declares that their artwork is not a copy, derivative or based on the work of others or in any way an infringement of copyright. The FCA reserves the right to reject submitted artwork that appears to be in direct violation of copyright law.

According to Canadian law the artist retains copyright of their work. If your work is successfully juried into this exhibition we may use the image on our website, posters and in other advertising media both printed and digital.

The FCA reserves the right to refuse entries that are not accurately represented by the digital photograph submitted for jury. All artwork must be signed by the artist on the front of the work.

Members may not enter a piece that was the result of a workshop or class. Only work that is new to the Federation Gallery may be entered for this call.

DELIVERY: Costs of shipping artworks to and from the gallery are the responsibility of the artist. If the artwork does not sell, the artist will be contacted directly to arrange for return delivery at their expense. DISPLAY: All canvases must be wired ready for hanging. Unwired works will incur a \$20 wiring fee. Works that do not fit this criteria, or arrive in disrepair will be removed from the exhibition.

INSURANCE: The FCA does not provide insurance for artwork. If the artist would like to insure their artwork during transit and exhibition, they must do so themselves.

PRICING: All artworks must be available for sale with prices listed in Canadian dollars. Artists are informed immediately when sales are made either by phone or email.

SUBMITTING INFORMATION: Artists cannot change details on their submission after the deadline for entries has passed. Attempts to change submitted information after the deadline, or when the artist delivers will not be honored

The artist is responsible for ensuring that the information provided at the time of submission is correct. This includes the correct orientation for and clarity of, uploaded JPEG images. Images submitted that are blurry, poorly

cropped, display a background, or are the wrong orientation will be declined without refund.

HOW TO ENTER

Submissions accepted online only at www.artists.ca be sure to select your preferred submission option as outlined below:

ENTRY FEES

| Donation Option | Donated Commission % | Fee |
|-----------------|-------------------------|---------------|
| Option 1 | 50% | \$10 per item |
| Option 2 | 100% | Free |

Artists can upload five images and deliver all five artworks. Please wait for confirmation of your acceptance and for an emailed notification and waiver before delivering. FCA staff will not submit for you. A minimum of three works per artist will display at one time during the exhibition.

CONDITIONS

Submission of entry to this exhibition automatically constitutes the entrant's acceptance of the guidelines and rules outlined in this booklet.
