The Federation of Canadian Artists (hereafter referred to as the "FCA") agrees to accept artwork on

By signing and initialing this document, both parties agree to each stipulation listed in this Agreement:		
The following commission/payment terms will apply to each consigned artwork sold by FCA unless otherwise expressly stated: 35% commission to FCA, 65% payment to ARTIST. ARTIST retains ownership of all work consigned to or represented by the FCA. ARTIST retains		
ARTIST agrees that the FCA may use an image of their art for promotional purposes whether online or in print, for supporting exhibition materials, or for any other FCA function.		
ARTIST declares that the work they submit is original and not taken from any source of another's work and that they hold the copyright to this work or have written permission from the owner of the copyright to use the image in their original art work.		
Works created under the supervision of an instructor are not eligible for juried shows.		
Payment to ARTIST will be processed within approximately 30 days after receipt of payment from Buyer to the FCA. This delay in payment is due to our return policy.		
Acceptance of installment payment on a sale will be subject to agreement by ARTIST. Under this agreement ARTIST agrees to accept partial payments as received by the FCA. Artwork will not be released by the FCA to Buyer until full payment is received. Upon ARTIST request, FCA will provide ARTIST with account statements of sales activity.		
3. The FCA will not maintain insurance for said artwork. Reasonable efforts will be made to protect consigned artwork from accidental damage or breakage but we encourage everyone to maintain their own insurance.		
9. The FCA agrees to hold on premises and display as appropriate all artwork described on attached inventory, which is an addendum to this CONTRACT. TERM of this CONTRACT begins:
