**Location and History:**

The Gallery of the Federation of Canadian Artists (FCA) is located at 1241 Cartwright Street, Vancouver BC, on Granville Island. Conveniently located across from the historic Granville Island hotel, Granville Island is known worldwide as a destination for arts and culture. The island boasts a vibrant cultural community of over 250 businesses, organizations and institutions dedicated to culture, tourism and the arts.

Founded in 1941 by Members of the Group of Seven, the Federation of Canadian Artists took up residence on the island in 1993. The organization was founded with the intent to promote and support the visual arts and visual artists in Canada. We achieve this through exhibition, networking and educational opportunities for emerging and established artists.

\*The FCA can provide 15 chairs for any special events or demonstrations associated with your rental. Clients hosting more than 15 guests at their event can arrange for chair / table rental through the FCA for an additional fee.

**Rates:**

Weekly rentals with the FCA run from **Monday – Sunday, 10 AM – 4 PM** daily. If you require earlier opening or later closing times, please contact the Gallery Coordinator.

Rates include the cost of one mandatory member of staff to be present for the entirety of the rental, to facilitate sales and for fire, health and safety purposes.

FCA staff are fully trained in fine art sales, liaising with artists, following up on leads, educating clients about your artists and their artwork. Sold artworks are wrapped beautifully for client collection and delivered to clients at their request.

By renting with the FCA you agree to provide one representative from your organization, collective or an assistant to be present during opening hours as the information source for your rental.

Rates do not include installation of artwork. The renter must provide their own installation team and install their exhibition at a pre-agreed time, as determined with the FCA Gallery Coordinator.

Basic installation hardware such as nails, hooks, hammers and ladders are provided. The FCA does not permit installation of artworks that need to be physically screwed into or damage the structure or walls of the gallery.

If you would like the Gallery Coordinator to plan your installation and oversee your installation team, the hourly rate for their services is \$30.

Organizations are responsible for providing their own labels and promotional literature.

For ease of exhibition organization, renters can opt to pay an additional \$150 for the **Complete Rental** which includes:

- Access to the FCA online submission system,
  - take away stress of organizing artworks, artwork details and artists. Have your artists submit their artwork online themselves.
- Gallery Coordinator administration of submissions
  - let us ensure your artists are submitting correctly so that we can provide you with an exhibition pack with automatically generated documents and features such as:
    - E-mailed notifications of when and where your artists should collect / deliver their artwork
    - An online gallery of your artists' artworks which doubles the potential for sales with an online shopping feature
    - Sign In / Sign out sheets to track artwork delivery
    - Artwork labels for exhibition
- An exhibition plan
- Installation assistance from the Gallery Coordinator

### **Deposit:**

A non-refundable deposit of 50% of the total cost of the rental is due at the time of booking. The remaining balance is due two weeks prior to the rental start day.

### **Rental Schedule:**

Rental for exhibitions are scheduled in accordance with the Federation of Canadian Artists' Annual gallery plan. Rentals are not accepted during the busier months from June – September.

### **Cancellations:**

The 50% deposit is non-refundable. Full refunds, minus the deposit, will be issued to cancellations made three months prior to the rental date. Cancellations made after this time will incur the full cost of the rental.

### **GST Number:**

Please let us know at the time of booking if you have a GST number.

### **Special Occasion Licenses:**

If you'd like to serve alcohol at a special event associated with your exhibition, you must obtain a Special Occasion License and have a Serving It Right Certified person responsible for the service. The FCA can provide this for you, at an additional cost. Prices vary depending on the number of guests.
