The FCA supports and promotes the visual arts in Canada through education, exhibition and communication. Founded in 1941 by Members of the Group of Seven, we hold a variety of workshops, classes and professional development courses in the Spring and Fall. Annually we host between 18-28 exhibitions from our permanent gallery space on Granville Island in Vancouver, BC.

We have between 2 – 5 open calls for submissions per year. These calls are open to all artists and you do not need an FCA membership to participate in them. The remainder of our exhibitions are member only, so we strongly recommend a membership! With over 2,600 members and 11 Chapters across B.C and Alberta, we represent a diverse and dynamic artist membership and are recognized as an exhibitor of high quality artworks with exceptional standards.
