## APPLICATION FOR ACTIVE STATUS

<u>Please note:</u> To apply for Active status you must first be a <u>Supporting member in good standing</u>. Active status is awarded to Supporting members, pending a successful jury process.

We aim to process all active applications within two weeks of the application date. We recommend that applicants opt to be juried via their professional website, as this is the most expedient method of jury.

## **JURY OPTIONS:**

#### 1) Jury through Vancouver Head Office

Submitting through the Vancouver head office is the most expedient way to be juried. You submit the completed application form along with the applicable items from the 'Applicant Checklist'.

A **non-refundable** \$15.00 jury fee applies when submitting through the Vancouver head office. Payment for the jury fee can be made online, by cheque or cash (*see page 3*). Once the jury process is complete, **successful applicants** will be contacted to pay a \$30.00 upgrade fee, in order to finalize their membership upgrade. This \$30.00 upgrade fee is basically the difference between the annual Supporting membership fee of \$50.00 and the annual Active membership fee of \$80.00.

## 2) Jury through FCA Chapters

The FCA has eleven Chapters across BC and AB. Some FCA Chapters provide jurying for Active Status.

Applicants juried **through their Chapter** must forward the completed and approved application form to the Vancouver head office and pay a \$30.00 upgrade fee. Phone calls, emails without approved application forms and hand written letters will not be accepted as proof of jury. Whether or not there is an upgrade fee required by the Chapter is up to that Chapter.

At the same time, obtaining Active status through the Vancouver Head Office does not allow automatic entry into Chapter Shows. ## **IMPORTANT NOTES**

Incomplete applications will not be juried and all jury fees are non-refundable.

Please only select **one** method of jury from the selection given in the applicant checklist. (For example: Do not provide JPEG images **and** a website URL). Submitting more than one method will not affect the outcome of jury and will result in one option being chosen on your behalf for the jurors use.

#### Success

If you are successfully juried into Active Status you will be contacted to pay the \$30 Active Upgrade Fee to the Vancouver Head Office, which makes up for the difference between the annual Supporting membership fee of \$50.00 and the annual Active Membership fee of \$80.00. Once this fee is processed, your Active membership upgrade will be completed and the Active Status Package will be emailed to you. Active members must annually renew their membership in order to maintain their active status. Whether or not there is an upgrade fee required by the Chapter is up to that Chapter. Please contact your Chapter directly to discuss their associated membership fees.

#### **Decline**

Applicants for Active Status must be prepared to accept the decisions made on their application. The FCA offers Active Status Feedback sessions once a month, led by one of our Signature jurors. Details on the session available to you will be sent along with your "Declined" notice. Registration for these feedbac sessions are free of charge. By signing the application form you acknowledge that you have read and agree to these terms. Unsuccessful applicants are encouraged to **re-apply after six months** of the initial application with a different body of work.

#### **Allowed Media**

Acrylic, oil, watercolour, pastel, mixed media, graphite, ink, pen and pencil. Original hand pulled prints are eligible in runs of up to 200 in an edition. All artworks must be two dimensional.

## **Excluded Media**

Photography, digital artworks, giclees (whether hand modified or not), three-dimensional works (sculptures) and mechanical reproductions.

#### **Image Specifications**

Please ensure that the images you submit are cropped so that only the painting/image is visible. Use a photo or image editing program to remove unwanted parts, such as frames or borders.

Images must be a true copy of the original art work in values, intensity and colour. File format must be JPEG (.jpg) only. Non-JPG files will NOT be converted by the office.

## **Further Information**

When submitting websites and JPEGS, present images which reflect the **strongest examples** of your current body of work. Jurors look for works which contain a working understanding of the use of line, color, composition, perspective, shape, light, proportion and positive and negative space. Jurors are also looking to see evidence of progression and a desire to progress in your artistic practice, along with evidence of exploring, establishing and developing a personal style.
