About the Exhibition:

Animalis is the Latin word for “air” and “soul”. Previously called “Wildlife” – this exhibition has opened up to accept all artwork featuring animals, including domestic pets and farmland creatures. Blow us away with your wild and lively creatures, your tame and endearing critters, furry friends and working companions.

GUIDELINES SPECIFIC TO THIS EXHIBITION

JURY: Entries will be reviewed by two SFCA Member and one AFCA member. Please check the submission page for juror names.

Images will be reviewed independently online by each juror. Successful images are considered by the panel as a group for awards when the exhibition is on display. All artists will receive emailed notifications of their results. Artists may not send artworks that have not been juried and may not send artworks unless they receive an acceptance email.

MEDIA: Acrylic, graphite, ink, mixed media, oil, pastel, pen, pencil, water media and hand pulled prints in runs of up to 200. All artwork must be two dimensional, signed and completely dry (no tacky surface).

EXCLUDED MEDIA: Photography, digital photography, digital prints, digital art, posters, pyrography, giclée, mechanical reproductions, and works that rely heavily on mechanical reproductions are not permitted

SIZE: Artworks may not be larger than 96" tall or 48" wide. Works on cradled wood panel or canvas must be at least 1" 1/2 thick.

STYLE: All styles are permitted

SUBJECT MATTER: For the purpose of this exhibition artworks featuring plants, trees and humans are not permitted. All other animals, including fish and insects are allowed. Artists must have taken their reference photography themselves. Artists who've paid for licensing to use stock photography obtained from online artists or another photographer may not submit images derived from this source.

While this is not an infringement of copyright, the Federation is committed to preserving the artistic integrity of our member artists in so much that they are responsible for all of the artistic decision making that has gone into their finished artworks. In the case of stock photography, another artist, namely the photographer, has already made a lot of artistic choices on behalf of the artist, including subject, composition and so forth.

We are a standards based organization, committed to the development of our artist members. If you cannot submit an artwork without it infringing on this requirement, this is not the exhibition for you.

PRESENTATION: Framed and unframed artwork are permitted for this call.

Edges of works on cradled wood panel or canvas must be completely void of paint, or completely covered in a complimentary colour, or be a continuation of the artwork. Staples must be on the back of gallery wrapped canvases.

Works on paper must be finished to an archival standard and either framed or adhered to a gallery wrap canvas or cradled wood panel. No "teeth" fixtures or French cleats are permitted. We will not hang directly from frame or canvas on a nail. All substrates must be wired with d-rings and plastic coated picture hanging wire, regardless of size. Improperly wired works will incur a \$20 wiring fee.

All artworks must be ready-to-hang. If an artist is successful and delivers a framed artwork, or a piece that clearly contravenes the presentation requirements outlined in this Call Booklet, their piece will be automatically removed from the exhibition and returned to the artist at their expense, without refund of any associated submission fees.

Works that arrive in disrepair will be fixed where possible, at the expense of the artist, or removed from the exhibition. Visit the "Member Resources" page at www.artists.ca to see further requirements.

GENERAL FCA SUBMISSION GUIDELINES

COPYRIGHT: While using photos as reference for painting is a long-held accepted practice, using stock imagery or photos taken by professional photographers is not permissible, even with permission or paid licensing.

All artists submitting to Federation Gallery must sign an Exhibition Contract including a waiver that declares their artwork is not a copy, derivative or based on the work of others or in any way an infringement of copyright. The FCA reserves the right to reject submitted artwork that appears to be in violation of copyright law. According to Canadian law the artist retains copyright of their work. By submitting to this exhibition, you allow the Federation of Canadian Artists permission to use your image on our website, posters and in other advertising media both printed and digital.

The FCA reserves the right to refuse entries that are not accurately represented by the digital photograph submitted for jury. All artwork must be signed by the artist on the front of the substrate.

Members may not enter a piece that was the result of a workshop or class. Only work that is new to the Federation Gallery on Granville Island may be submitted. Work that has shown in a Chapter exhibition may be submitted.

DELIVERY: Costs of shipping artworks to and from the gallery are the responsibility of the artist. Artists are responsible for the cost of any customs, import or additional postage or shipping expenses that incur while delivering to the gallery. If the artwork does not sell, the artist will be contacted directly to arrange for return delivery at their expense. INSURANCE: The FCA does not provide insurance for artwork. Artists are responsible for arranging their own insurance during transit and exhibition.

PRICING: Submitted artworks must be available for sale. Artworks submitted “Not for Sale” or “Sold” will be declined without refund. Please note our submission system appears to give the option of the availability of your pieces, as it is a generic system used for all of our calls. So while you can select alternative options, the only entries accepted for display will be those available for sale.

SALES: If a sale is made artists will be informed by phone or email. Artwork must be available for sale throughout the entire period of the exhibition. By submitting their artwork to this call the artist agrees to allow the Federation to negotiate a sale on their behalf including up to 10% off of the artist’s submitted sale price. In addition, the Federation will collect a commission at a rate of \$50 or 35%, whichever is greater. Payment to artists will be made by cheque. If an artwork is sold from the online gallery the Federation will ask the artist to package their artwork and the Federation will arrange and pay for the shipping to the client.

SUBMITTING INFORMATION: Images submitted to the online submission system that are blurry, poorly cropped, display a background/frame, were made in error, or are the wrong orientation will be declined without refund. When submitting online, crop your image to exclude visible edges of substrate. The description of your piece should be one to two sentences long, aiming to enhance a viewer’s interest in the artwork. This description will be printed on your in-gallery label so please proof read and spell check it.

Artists cannot change details on their submission after the deadline for entries has passed. Attempts to change submitted information (including prices or sizes) after the deadline, or when the artist delivers will not be honored. The artist is

responsible for ensuring that the information provided at the time of submission is correct and spelled correctly.

HOW TO ENTER: This call is open to Active and Signature Members. Submissions are accepted online only at www.artists.ca Artists must submit as early as possible to allow time for troubleshooting. If you have require assistance, contact the Gallery Coordinator at gc@artists.ca no less than three days prior to the deadline. Artists submitting at the last minute may not be able to receive the assistance they need.

ENTRY FEES: are non-refundable and accepted in Canadian dollars only at \$15.00 for your submission and first submitted image. Further submitted images are \$15 per image. Artists can submit up to five images. If successful at jury, one image per artist will be displayed.

CONDITIONS: Submission of entry to this exhibition automatically constitutes the entrant's acceptance of the guidelines and rules outlined in this booklet. Due to the volume of entries, the FCA and their jurors do not provide individual feedback on submissions. The juror's decision is final, submissions to this exhibition declares your acceptance of their decision.

April 23, 2020	Applicants informed of their result by this date at the latest. Contact the FCA if you do not receive notice by this date. The artist is responsible for contacting the office if they do not receive notice
Apr 24 – May 10, 2020	Delivery Window. Artwork must be delivered before 4 PM on the final day of the delivery window. May 12, 2020	First official day of exhibition 10 AM – 4 PM, and awards jury. Award winners will be contacted.
May 24, 2020	10 AM – 3 PM Last day of exhibition. No artwork will be picked-up by artists today.
May 28, 2020	Artists can collect artworks in person from the gallery as of today. Artists are responsible for collecting their artwork within two weeks of the last day of exhibition. Failure to do so will result in the Federation claiming and/or disposing of your artwork.
June 15, 2020	Delivered and couriered artworks will be shipped out of the gallery by this date at the latest.
