Send the entire form with a suitably stamped, self-addressed return envelope, fee of \$15 per digital or slide entry (use only one format), to Federation Gallery by the deadline listed on the Calendar of Events. **PLEASE NOTE NEW FEE: \$15 per entry.**

3. Mat and frame, if appropriate, your accepted work(s). Paper mats must be presented under glass. Unframed canvases must have staples on the back and edges professionally finished. The hanging wire must be taut and the findings close enough to the upper edge that the painting hangs flat against the wall. 1) Pricing: please provide an unframed price only if you want to sell a work without its frame. This is not recommended for custom-sized frames you will not want to re-use.

2) Gallery staff are not jurors and cannot comment on either accepted or declined entries.

3) Please do not call the Gallery for your jury results, they will be returned by mail as soon as possible.

RESTRICTIONS TO BE AWARE OF:

1) Works created in workshops and/or classes are not eligible for entry in juried shows whether the instructor made any marks on the image or not. They are eligible for submission to the annual Student Show.

2) Federation Gallery is unable to hang paintings which are not for sale, except during the exhibition of successful Signature applicants which follows the Board of Governors meeting and the Student Show.

3) For the protection of the artist, paintings with unsigned labels cannot be hung in the gallery. Please ensure that your labels are completed in full and that the price is correct.

4) The FCA takes every measure to avoid damage and protect the artwork kept in the Gallery. However, the insurance for this type of coverage being too rich for a non-profit society we require a waiver from our participants. Your signature on the FCA Painting Label indicates a signed Release Waiver.
