### **ABOUT THE EXHIBITION**

Annual online-only exhibition for seasonally themed artworks. Artists can submit for sale, not for sale and sold artworks for juror consideration. The top 14 artists have their artwork featured in the printed official 2023 Federation Art Calendar. This calendar is sold from the Federation Gallery and [artists.ca](http://artists.ca) to raise funds and awareness for the Federation as a non-profit arts service organization

### **2022 AWARDS**

Awards will be given for First, (\$500CA) Second (\$300 CA) and Third Place (\$200 CA) in as well as up to 3 Honourable Mentions in title. Award winners also receive an official certificate and acknowledgement at [artists.ca](http://artists.ca) All artworks successful at jury feature in the online gallery at [federationgallery.com](http://federationgallery.com)

## **GUIDELINES SPECIFIC TO THIS EXHIBITION**

This intake is open to **painting, drawing, collage, mixed media and hand-pulled prints**. Submitted artworks must demonstrate concept, manipulation of materials, and evidence of the aesthetic judgment of the creator. Artwork must be "one-of-a-kind", meaning that the production techniques exposes each work to the possibility of uniqueness and where the reproduction series is limited to less than 200. All artworks must be finished to an archival standard and last up to a hundred years without a controlled display environment. **At this time, the Federation does not represent photographers.**

**PRESENTATION:** Framed and unframed artwork is permitted to this call. All submissions must be able to be installed by a potential client without additional or special consideration. **Federation clients are familiar with a certain standard of presentation. Your online submitted artworks must meet the following presentation requirements, even with online-only exhibitions:** Edges of artwork on cradled wood panel must be completely void of paint or completely covered in a complimentary colour or continuation of the artwork. Edges of work on gallery wrapped canvas can either be a continuation of the artwork or painted in a complimentary colour. No taped edging is permitted. All substrates must be wired a third of the way down from the top with d-rings and plastic coated picture hanging wire, regardless of size. Only submit pieces that are client-ready. This means completely dry and varnished or finished to an archival standard. If the work is on paper, this means framed and ready for a client to put on their wall.

**SIZE:** There are no size restrictions on this call for entry AND thinner than 1 1/2 inch profile canvases and substrates ARE permitted.

**SUBJECT MATTER:** Submissions that are seasonal do well for this call for entry. Think spring blooms, summer days, autumn leaves and winter snow. If you have artwork that is reflective of a specific month or holiday, valentine's day or new years' day for example, they do well also.

**STYLE:** All styles are permitted

## **GENERAL FCA SUBMISSION GUIDELINES**

**COPYRIGHT AND STANDARDS:** While using photos as reference for your artwork is a long-held accepted practice, using stock imagery or photographs taken by professional photographers is not permissible in our organization, even with permission or paid licensing. All artists submitting to Federation Gallery must sign an Exhibition Contract that declares their artwork is not a copy, derivative or based on the work of others or in any way an infringement of copyright. The FCA will reject submitted artwork that appears to be in violation of copyright law. The FCA reserves the right to refuse entries that are not accurately represented by the digital photograph submitted for jury. Members may not enter a piece that was the result of a workshop or class. Only work that has not featured in an online-only Federation exhibition may be submitted. If your artwork has exhibited as "Recognized" for an in-gallery exhibition, it may be resubmitted for this call.

**DELIVERY:** Costs of shipping artworks to clients, including customs, import fees or additional postage are the responsibility of the purchasing client. When a sale is made, our Sales Team will contact you with further instructions. See “Sales”.

**INSURANCE:** The FCA does not provide insurance for artwork. Artists are responsible for arranging their own insurance during transit to clients.

**JURY:** Entries will be reviewed by two SFCA Members and one AFCA member. Please check the submission page for juror names. Images will be reviewed independently online by each juror. All artists will receive emailed notifications of their results. Artists attempting to contact jurors directly in relation to their submission will be suspended from the organization for three months. Your submitted pieces will receive one of the following jury results:

**Accepted** –artwork has been chosen for exhibition in the online-gallery

**Declined** - artwork was not chosen for exhibition this time

**PRICING:** Submitted artworks can be for sale, sold and not for sale. Artists cannot change submitted prices **at any time**. Please factor in the cost of your display materials (frames for example) when submitting prices. The minimum price for artworks is \$200. While there is no maximum price, artists are reminded that if they cannot provide evidence of a recent sale in that price range, artworks with artificially inflated prices will be removed from the exhibition.

**SALES:** Artwork is under contract with the Federation effective of the date notification emails are sent. If a sale is made artists will be informed by phone or email. By submitting their artwork to this call the artist agrees to allow the Federation to negotiate a sale on their behalf including up to 10% off of the artist’s submitted sale price. The Federation collects a commission rate of 35% of artwork prices, whichever is greater. Following a sale, payment to artists will be made by cheque. When artwork is sold from the online gallery, the Federation will ask the artist to package their artwork and the Federation will arrange and pay for the shipping to the client, at the client’s expense.

**SUBMITTING INFORMATION:** Submitted images that are blurry, poorly cropped, display a background/frame, were made in error, or are the wrong orientation will be declined without refund. When submitting online, crop your image to exclude visible edges of substrate. The description of your piece should be one-two sentences long, aiming to enhance a viewer’s interest in the artwork and encourage sales. Please proof read and spell check it. Artists cannot change details on their submission after the deadline for entries has passed. Attempts to change submitted information after the deadline will not be honored.

**REMOVAL FROM EXHIBITION:** The Federation reserves the right to remove artwork from any exhibition at any time. If an artist withdraws or sells an “Accepted” artwork after receiving their notification email, for any reason, the artist is subject to a \$100 removal fee. Artists will not be able to participate in future Federation exhibitions until this fee is paid. Artists removing “Accepted” artworks will also lose their online gallery representation. If you are unsure if you can honour a commitment to exhibit, please do not submit. If artists have an interested client and they direct sales through the Federation prior to the

exhibition start date, they will be able to exhibit as “sold” for the duration of the exhibition.

**HOW TO ENTER:** This call is open to Active, Associate and Senior Members of the Federation of Canadian Artists. Submissions are accepted online at [www.artists.ca](http://www.artists.ca) Artists must submit as early as possible to allow time for troubleshooting. If you require assistance, contact the Gallery Manager at [gc@artists.ca](mailto:gc@artists.ca) no less than 3 days prior to the deadline. Artists submitting at the last minute may not receive the assistance they need.

**ENTRY FEES:** are non-refundable and accepted in Canadian dollars only at \$15.00 for your submission and first submitted artwork. Further submissions are \$15 per artwork. Artists can submit up to five artworks for consideration. If successful at jury, a minimum of one artwork per artist will be displayed for the duration of the exhibition.

**CONDITIONS:** Submission of entry to this exhibition automatically constitutes the entrant’s acceptance of the guidelines and rules outlined in this booklet. Due to the volume of entries, the FCA and their jurors do not provide individual feedback on submissions. The juror’s decision is final, submission to this exhibition declares your acceptance of their decision.
