HOW TO ENTER

GENERAL INSTRUCTIONS & SCHEDULE

- Submissions deadline is August 13, 2010.
- Maximum of 3 entries per artist.
- Complete this form and sign as indicated. **KEEP PAGE 1** for your records. **MAIL PAGE 2** along with a stamped self-addressed envelope and your entry fee to FCA-COC, Kelowna
- Send digital images of art work to:

- Each digital file must be titled as follows:
last name, first name, title, size, medium, price.jpg (e.g. Smith, Joe, After the Rain, 12 x 18, acrylic, \$400.jpg)
- **PLEASE BE SURE YOUR DIGITAL TITLES ARE EXACTLY AS ABOVE.** Handling the large number of entries is difficult and incorrectly titled images can get lost.
- Digitals should be at least 1200 to 1500 pixels a side at 300dpi
- Submissions will be independently juried by the FCA head office, Vancouver. Artists will be notified by e-mail of the jury results by September 7.
- Accepted images must be delivered in Kelowna by October 1.
- A second local jury will select award winners on October 2.
- The Opening Ceremonies will be in the evening, October 7.
- Unsold images are to be collected October 16 or 18, or returned COD by courier. (Instructions on sending and collecting images will be given to accepted submissions.)

FILLING OUT THIS FORM

- **PAGE 1:** Complete and sign a painting label for each image you are submitting. **KEEP PAGE 1** for your records and for your labels which you will need later for accepted images. (Do NOT mail us the image labels at this time.)
- With 4 galleries involved we cannot have separate prices for framed and unframed images. Quote one price for each image as you will be sending it, either framed or unframed.
- The galleries will withhold a 30% commission on all sales, be sure your prices reflect this.
- **PAGE 2:** Fill in your name, address, phone, e-mail address, membership status, local chapter and GST number (if applicable). Complete the details of the images you are submitting, and sign the release/copyright statement.
- If you want a receipt for your submissions fee, complete the 'Receipt for Jury Fees' on the bottom of page 2. (Note: **NO FEES** are required for **SFCA** submissions as these are not juried, but accepted on a first-come-first-served basis.)

A cheque made payable to FCA-COC for your submissions fee of \$20 per image, and
A stamped self-addressed envelope.

RESTRICTIONS TO BE AWARE OF:

- 1) This is an FCA show; all FCA requirements apply.
- 2) Works created in workshops and/or classes are not eligible.
- 3) All accepted entries must be available for sale in the show.
- 4) For the protection of the artist, paintings with unsigned labels cannot be included in the show. Please ensure that your labels are completed in full and that the price is correct.

- 5) Maximum IMAGE size is 60" height or width.
- 6) Mat and frame, if appropriate, your accepted work(s). Mats must be white, off-white or neutral in colour. Paper mats must be presented under glass. Unframed canvases must have staples on the back and edges professionally finished. Works must be properly wired for hanging. See www.artvisions.ca for more information

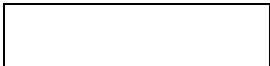
