If submitted as "for sale", artwork will be for sale on consignment from the date of receipt of acceptance of your new status. By signing this document, the ARTIST agrees, understands and is in compliance with each stipulation listed:

- 1. Unless ARTIST has opted out of the opportunity to exhibit, artwork from successful applicant portfolios will exhibit in the Federation Gallery from April 23 May 5, 2024.
- 2. If submitted as "for sale" the following commission/payment terms will apply to each consigned artwork sold unless otherwise expressly stated: 35% commission to FCA, 65% payment to ARTIST.
- 3. The FCA is at liberty to negotiate a discount of up to 10% of the ARTIST's declared sale price.
- 4. ARTIST retains ownership of all work consigned to or represented by the FCA.
- 5. While ARTIST retains copyright to all consigned artwork, as governed by law, ARTIST agrees that the FCA may use an image of their art for promotional purposes whether online or in print, for the promotion of the exhibition or for any other FCA function.
- 6. ARTIST understands that only use of photographic reference images, not taken by the artist themselves, is prohibited by the FCA, regardless of if the artist has purchased a copyright. Artwork found to be in contravention of this will be removed from the exhibition and Signature Status will be revoked.
- 7. ARTIST understands artwork is under contract with the gallery, from the date ARTIST receives notifications of their new membership status.
- 8. ARTIST agrees to direct all sales inquires for "for sale" work to the Federation Gallery's Fine Art Consultant via <u>sales@artists.ca</u> starting from the date of an acceptance notification until the last date of exhibition.
- 9. Payment from sales to ARTIST will be processed approximately 30 days after receipt of payment from the Buyer to the FCA. This delay in payment is due to our return policy.
- 10. Acceptance of installment payment on a sale will be subject to agreement by ARTIST.
- 11. The FCA will maintain insurance for fire and theft, and declares that all consigned artwork will be covered by said insurance while in FCA possession. Reasonable efforts will be made to protect consigned artwork from accidental damage or breakage. By signing this waiver, you agree to not hold the FCA, their staff, volunteers and representatives responsible for damage or loss. You agree to maintain responsibility of any costs associated with loss or damage to artworks, frames or display materials.
- 12. ARTIST will remain responsible for insurance on artwork while artwork is in transit and for accidental damage and breakage. ARTIST is responsible for any costs incurred for delivery or return.
- 13. Artwork left for more than two weeks after the end of the contract term will become property of the FCA.
