## ABOUT THE EXHIBITION

This online-only exhibition is the Federation's annual exhibition of artworks that explore the visual language of shapes and forms. This exhibition lends itself beautifully to sculpture, so there are two separate submission intakes. Be sure you're submitting under the correct intake!

## AWARDS

**Best Sculpture \$100 CA, Second Place, Third Place, and 3 x Honourable Mentions - Awards in Title.**

## GUIDELINES SPECIFIC TO THIS EXHIBITION

**FORMAT:** This is an online-only exhibition.

**PERMISSIBLE SCULPTING MEDIA:** stone, metal, glass, clay, wood, or ceramic.

**EXCLUDED SCULPTING MEDIA:** ivory, plaster, wax, reusable modeling compound, found objects, electronics, holography, and other projected media, and fragile modeling media such as paper-mâché and salt dough.

**ALL MEDIA:** must demonstrate concept, manipulation of materials, and evidence of the aesthetic judgment of the creator. Artwork must be "one-of-a-kind", meaning that the production techniques expose each work to the possibility of uniqueness, and where the reproduction series is limited to less than 200. All artworks must be finished to an archival standard and last up to a hundred years without a controlled display environment. For mixed media pieces, artists must list out the media they've used in their submissions.

**SIZE:** Open to Sculptures of any size and weight

**SUBJECT MATTER:** All subjects permitted **STYLE:** All styles permitted

## GENERAL FCA SUBMISSION GUIDELINES

**COPYRIGHT AND STANDARDS:** While using photographs as reference for your artwork is a long-held accepted practice, using stock imagery or

**photographs taken by professional photographers other than the submitting artist is not permissible in our organization, even with permission or paid licensing.** Artists submitting to the Federation Gallery must sign a contract that declares their artwork is not a copy, derivative, or based on the work of others or in any way an infringement of copyright. The FCA will reject submitted artwork that appears to violate copyright law. The FCA reserves the right to refuse entries that are not accurately represented by the digital photograph submitted for the jury.

Artists may not enter a piece that was the result of a workshop or class.  
**Important note:** Only work that has not been accepted previously into another Federation online-only exhibition may be submitted. Work that has been shown in a Chapter exhibition may be submitted.

**INSURANCE:** The FCA does not provide insurance for artwork. Artists are responsible for arranging their insurance during transit.

**JURY: Entries will be reviewed by a panel of three jurors. Please check the submission page for juror names.** Images will be reviewed independently online by each juror. All artists will receive emailed notifications of their results. Artists attempting to contact jurors directly about their submission will be removed from the exhibition.

Your submitted pieces will receive one of the following jury results:

**Accepted** –artwork has been chosen for the exhibition

**Declined** –artwork was not chosen for the exhibition this time

**PRICING:** This call for entry is open to available, sold, and not-for-sale artwork. On the submission page, you will be prompted to enter a price, regardless of the sales status of the piece. Artists cannot change submitted prices or availability (for sale to not for sale, etc.) **at any time.** The minimum price for artwork is \$200. While there is no maximum price, if the artist cannot provide evidence of a recent sale in that price range, artworks with artificially inflated prices will be removed.

**SALES:** For artwork that is for sale, the artwork is under contract with the Federation effective from the date notification emails are sent. Do not submit an artwork for sale if you intend to sell it yourself outside of the exhibition. If a sale is made, artists will be informed by phone or email. By submitting artwork to this call, artists agree to allow the Federation to negotiate a sale on their behalf, including up to 10% off of the artist's submitted sale price. Following a sale, payment to artists will be made by e-transfer or cheque within 30 days.

**MEMBER COMMISSION RATE: 65% to artists, 35% to Federation.**

**NON-MEMBER COMMISSION RATE: 50% to artists, 50% to Federation.**

**SUBMITTING INFORMATION:** Sculptors are given 3 image upload slots per sculpture in the submission system. This means you are expected to upload three photographs of 3 different views per sculpture (front/back/side are recommended). Submitted blurry images, poorly cropped, display a distracting background, were made in error, under the incorrect intake, exceed the size restrictions, or are the wrong orientation will be declined without refund. The

description of your piece should be one to two sentences long, aiming to enhance a viewer's interest in the artwork and encourage sales. Please proofread and spell-check it. Artists cannot change details on their submissions after the deadline for entries has passed. Attempts to change submitted information after the deadline, or when the artist delivers, will not be honoured

**REMOVAL FROM EXHIBITION:** The Federation reserves the right to remove artwork from any exhibition at any time. If an artist withdraws or sells an "Accepted" artwork after receiving their notification email, for any reason, the artist is subject to a \$100 removal fee. Artists will not be able to participate in future Federation exhibitions until this fee is paid. If you are unsure if you can honour a commitment to exhibit, do not submit. If artists have an interested client and they direct sales through the Federation before the exhibition start date, the artwork can still be exhibited in the exhibition as "sold" for the duration of the exhibition.

**HOW TO ENTER:** This call is an open International call for submissions. Submissions are accepted online at [www.artists.ca](http://www.artists.ca). Submit as early as possible to allow time for editing, if necessary. If you require assistance, contact the Gallery Coordinator at [fcagallery@artists.ca](mailto:fcagallery@artists.ca) no less than 3 days prior to the deadline. Artists submitting at the last minute may not receive the assistance they need.

**ENTRY FEES:** are non-refundable and accepted in Canadian dollars only. **FCA MEMBERS:** \$25.00 for your submission and first submitted artwork. Further submissions are \$20.00 per artwork. **NON-MEMBERS:** \$30.00 for your submission and first submitted artwork. Further submissions are \$25.00 per artwork. Artists can submit up to five (5) artworks for consideration. If successful at jury, a minimum of one (1) artwork per artist will be exhibited.

**CONDITIONS:** Submission of entry to this exhibition automatically constitutes the entrant's acceptance of the guidelines and rules outlined in this booklet. Due to the volume of entries, the FCA and its jurors do not provide individual feedback on submissions. The juror's decision is final; submission to this exhibition declares your acceptance of their decision.
